

BAC Resolution Declaring SCRB and Recommending Approval

RESOLUTION NO. 044(05-19)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Lot I** - One (1) Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Ventilation Equipment with an Approved Budget for Contract (ABC) of **TWO HUNDRED EIGHTY-FIVE THOUSAND PESOS (P285,000.00)**, VAT inclusive, and **Lot II** - One (1) Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Packaged Air-conditioning Units, with an ABC of **ONE HUNDRED EIGHTY THOUSAND PESOS (P180,000.00)**;


WHEREAS, in response to the said posting, only one (1) bidder, ROSE AIRE ENTERPRISE, INC. ("RAEI"), obtained and paid for the bid documents and submitted an application for eligibility on May 20, 2019. The bid proposals of RFFS were found to be complying:


