PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **RENATO B. PADILLA**, hereinafter to as **"PICCI"**.

and

ROSE AIRE ENTERPRISE, INC a company duly organized and existing under the laws of the Republic of the Philippines with office address at 13F Manalo St., Ligid, Tipas, Taguig City and represented herein by its President, **ROSELYN O. REYES**, duly authorized for the purpose, hereinafter referred to as **"CONTRACTOR"**.

WITNESSETH : That -

WHEREAS, PICC, through its Bids and Awards Committee (BAC), invited bids for the Lot I - One (1) - Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Ventilation Equipment and Lot II - One (1) - Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Packaged Air-conditioning Units and has accepted bids from the CONTRACTOR which gave the single calculated and responsive bids for **Lot I** in the total amount of **TWO HUNDRED EIGHTY-FIVE THOUSAND PESOS (P285,000.00)**, VAT inclusive and for **Lot II** in the total amount of **ONE HUNDRED EIGHTY THOUSAND PESOS (P180,000.00)**, VAT inclusive;

WHEREAS, the PICCI Management, approved, the award of the contract for the said projects to the CONTRACTOR, which offered the single calculated and responsive bid;

NOW, THEREFORE, PICCI and the CONTRACTOR hereby enter into this Agreement under the following terms and conditions;

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
2. The following documents shall be deemed to form, and be read and construed as, part of this Agreement, viz:
 - a. The Bid Proposal submitted on May 20, 2019, Eligibility Documents, Technical and Post-Qualification Documentse;
 - b. Section VI - Schedule of Requirements;
 - c. Section VII - Technical Specifications;
 - d. Section III - Bid Data Sheet;
 - e. Section IV - General Conditions of Contract;
 - f. Section V - Special Conditions of Contract (SCC);
 - g. Notice of Award; and
 - h. Performance Bond.

In consideration of the payment to be made by **PICC** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the services for the Lot I - One (1) - Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Ventilation Equipment and Lot II - One (1) - Year Contract for the Quarterly Preventive Maintenance Service of PICC Forum's Packaged Air-conditioning Units in conformity with the provisions contained in the approved Scope of Work;
4. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
