2. In consideration of the payments to be made by **PICCI** to **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the goods and services required under the one (1)-year contract subject of the public bidding in conformity with the provisions of the contract; and

3. The **PICCI** shall pay the **CONTRACTOR**, in consideration for the services rendered and goods delivered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
