This Agreement, entered into this _____ day of July 2019, in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **RENATO B. PADILLA**, hereinafter to as "**PICCI**".

and

UNISON COMPUTER SYSTEMS, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 120 E. Rodriguez Jr. Ave. Cor. Ortigas Ave., Brgy. Ugong, Pasig City and represented herein by its President, **WILLY SY**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

WITNESSETH : That -

WHEREAS, PICC, through its Bids and Awards Committee (BAC), requested for quotation for the **Two (2)-Year Contract for the Preventive Maintenance of Servers, Computers and Printers** and has accepted an offer from Unison Computer Systems, Inc. which gave the lowest calculated and responsive offer in the total amount of **TWO HUNDRED EIGHTY EIGHT THOUSAND PESOS (₱ 288,000.00), per annum, VAT inclusive;**



WHEREAS, the two (2)-year contract, will be effective from September 29, 2019 to September 28, 2021.



NOW THEREFORE, the parties hereby agree and covenant as follows:

- g. Notice of Award; and
- h. Performance Bond

2. In consideration of the payment to be made by **PICC** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the services for the Two (2)-Year Contract for the Preventive Maintenance of Servers, Computers and Printers in conformity with the provisions contained in the approved Technical Specifications;
