This Agreement, entered into this ___ day of November 2019 in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the CCP Complex, Roxas Boulevard, Pasay City, represented herein by its General Manager, Atty. RENATO B. PADILLA, hereinafter referred to as "PICCI".

CONVERGE INFORMATION & COMMUNICATIONS TECHNOLOGY SOLUTIONS INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at New Street Bldg. Mc Arthur Highway Balibago, Angeles City Pampanga and represented herein by its Key Account Manager, JETRO JUDE D. ISIDRO, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited bids for the Two (2) – Year Contract Subscription of 80mbps Internet Bandwidth Speed and has accepted a bid from the CONTRACTOR in the sum of FOUR HUNDRED EIGHTY-SIX THOUSAND FORTY-FOUR PESOS (₱486,044.00), per year, VAT inclusive; and

WHEREAS, the PICCI Management, approved, the award of the contract for the said project to the CONTRACTOR, which offered the single calculated and responsive bid. The contract period shall be from January 7, 2020 to January 6, 2022;

NOW, THEREFORE, PICCI and the CONTRACTOR hereby enter into this Agreement under the following terms and conditions;

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
2. The following documents shall be deemed to form, and be read and construed as, part of this Agreement, viz:

- a. The Bid Proposal submitted on September 11, 2019, Eligibility Documents, Technical and Financial Components of the Bid;
b. Section VI – Schedule of Requirements;
c. Section VII – Technical Specifications;
d. Section III – Bid Data Sheet;
e. Section IV – General Conditions of Contract;
f. Section V – Special Conditions of Contract (SCC);
g. Notice of Award; and
h. Performance Bond.
