KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this ^{NOV 25 2019} ~~NOV 27 2019~~ day of November 2019, in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **Atty. RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

and

STAGE CRAFT INTERNATIONAL, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 888 E. de los Santos Avenue, Mandaluyong City, represented herein by its President, **MR. FRANCISCO N. ZABALA**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

WITNESSETH: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for a One (1) - Year Contract for Monthly Operation and Maintenance of PICC Audio Visual Equipment/System and has accepted from Stage Craft International, Inc., who gave the single calculated and responsive bid in the amount of **TWO MILLION FIVE HUNDRED NINETY-THREE THOUSAND NINE HUNDRED NINETY-NINE PESOS AND NINETY-TWO CENTAVOS (P2,593,999.92)**, VAT inclusive;

WHEREAS, the contract will be effective from January 27, 2020 to January 26, 2021;

NOW THEREFORE, the parties hereby agree and covenant as follows:

2. In consideration of the payment to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the required services for the One (1) - Year Contract for Monthly Operation and Maintenance of PICC Audio Visual Equipment/System subject of the public bidding in conformity with the provisions of the SCC and with a contract period from January 27, 2020 to January 26, 2021; and
