

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 019(074-20)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Electrical and Electronics Supplies, Parts and Materials consisting of seven (7) lots, with an Approved Budget for Contract (ABC) of **FIVE MILLION SEVEN HUNDRED NINETY-NINE THOUSAND NINE HUNDRED THIRTY-SEVEN PESOS (P5,799,937.00), VAT Inclusive;**

WHEREAS, the sub-ABCs are as follows; **Lot I** – One Million Four Hundred Forty Thousand Two Hundred Ninety Pesos (**P1,440,290.00**); **Lot II** – Four Hundred Sixty-five Thousand Pesos (**P465,000.00**); **Lot III** – Six Hundred Twenty-Two Thousand Five Hundred Five Pesos (**P622,505.00**) and **Lot IV** – Two Million Four Hundred Forty-Nine Thousand Pesos (**P2,449,000.00**); **Lot V** – Ninety-One Thousand Six Hundred Seventy-Two Pesos (**P91,672.00**); **Lot VI** – Two Hundred Seventy-Nine Thousand One Hundred Twenty Pesos (**P279,120.00**) and **Lot VII** – Four Hundred Fifty-Two Thousand Three Hundred Fifty Pesos (**P452,350.00**);

WHEREAS, in response to the said posting, three (3) suppliers, namely: SUPERSERVE CORPORATION("Superserve"), EROSA TRADING ("Erosa") and INNOVALITE ELECTRICAL ENTERPRISES ("Innovalite") obtained/paid for the bid documents. Erosa was declared Ineligible for failure to submit Section VIII – Bid Forms of the bidding document. Superserve and Innovalite were declared ELIGIBLE and their bid proposals submitted were found to be substantially complying:




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend to the PICC General Manager the award to Superserve which submitted the single calculated and responsive bid for Lot V – Wires and Cables, whose total offer of ₱90,720.00 is within the sub-ABC;
- c) To declare a Failed Bid for Lots I, II, III, VI and VII and schedule a **RE-BID** to for such requirements.


