

**BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL**

**RESOLUTION NO. 057(12-20)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of One (1) unit Mobile Vertical Lift (Re-bid)**, with a total Approved Budget for the Contract (ABC) of **ONE MILLION NINE HUNDRED TWENTY-SIX THOUSAND PESOS (P1,926,000.00), VAT inclusive;**

WHEREAS, in response to the said posting, five (5) bidders obtained and paid the bid documents namely: **RIMPORT INDUSTRIES, INC ("RII"), WILAN MERCHANDISING PHILS. ("WMP"), PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORP. ("PROMATECH"), MARKO TEKNOLOGIQUES, INC. ("MTI")** and **CIVIC MERCHANDISING INC. ("CMI")**. All bidders were declared Eligible during the public bidding on November 26, 2020 and their bid proposals were found to be substantially complying:


