**WHEREAS**, the PICCI Management, has approved, the award of the said procurement to the SUPPLIER, which offered the lowest calculated and responsive bid;



**NOW, THEREFORE**, the PICCI and the SUPPLIER enter into this Agreement under the following terms and conditions;


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;



2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:


