and

MONIS JR.**, duly authorized for the purpose, hereinafter referred to as **“CONTRACTOR”**.

**WITNESSETH : That -**

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids for a One (1) – Year Service Contract for the Daily Operation and Preventive Maintenance Service of PICC’ Sewage Treatment Plant (STP) System and has accepted a bid from the CONTRACTOR which gave the single calculated and responsive bid in the total amount of **SEVEN HUNDRED FIFTY-NINE THOUSAND PESOS (P759,000.00), per annum, VAT inclusive;**
