KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this 1 JAN 18 2021 day of 2021, in the City of Pasay, Philippines, by and between: **QUEZON CITY**

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **Atty. RENATO B. PADILLA**, hereinafter referred to as “**PICCI**”.

and

TRITON COMMUNICATION CORPORATION, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at Unit 2706 Antel Global Corporate Center, Julia Vargas Ave., Ortigas Center, Pasig City, represented herein by its Chairman, **MR. AQUILINO C. ORETA**, duly authorized for the purpose, hereinafter referred to as “**CONTRACTOR**”.

W I T N E S S E T H: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the **Supply, Delivery, Installation and Commissioning of Digital Radio Communication System** and has accepted from CONTRACTOR, in the total amount of **ONE MILLION THREE HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED EIGHTY PESOS (P1,378,380.00)**, VAT inclusive;

WHEREAS, the PICCI Management, approved, the award of the contract for the said projects to the CONTRACTOR, which offered the single calculated and responsive bid;

- h. the Notification of Award

2. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;


