RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

W I T N E S S E T H: That -



WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply of Labor and Materials for the Installation of New Carpets at the Plenary Hall and has accepted bid from CONTRACTOR in the total amount of **ELEVEN MILLION SIX HUNDRED FORTY-ONE THOUSAND NINETY-ONE PESOS AND TWENTY CENTAVOS (P11,641,091.20)**, VAT inclusive;

WHEREAS, the PICCI Executive Committee, in its meeting held on November 17, 2020 has approved the award of the contract for said project to the CONTRACTOR, which offered the single calculated and responsive bid;

NOW, THEREFORE, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Bid Proposal submitted on September 28, 2020, Eligibility, Technical and Post-Qualification Documents;
 - b. Section VI – Schedule of Requirements;
 - c. Section VII – Technical Specifications;
 - d. Section III – Bid Data Sheet;
 - e. Section IV – General Conditions of Contract;
 - f. Section V – Special Conditions of Contract;
 - g. the Performance Security; and
 - h. the Notification of Award
2. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
3. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
