

A G R E E M E N T

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this 26 day of JAN 26 2021 2021, in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, **Atty. RENATO B. PADILLA**, hereinafter referred to as "**PICCI**".

and

STAGE CRAFT INTERNATIONAL, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 888 E. de los Santos Avenue, Mandaluyong City, represented herein by its President, **MR. FRANCISCO N. ZABALA**, duly authorized for the purpose, hereinafter referred to as "**CONTRACTOR**".

W I T N E S S E T H: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for a Operation and Maintenance of PICC Audio Visual Equipment/System and Its Accessories and has accepted from Stage Craft International, Inc., who gave the single calculated and responsive bid in the amount of **TWO MILLION SIX HUNDRED FIFTY-EIGHT THOUSAND SEVEN HUNDRED PESOS (P2,658,700.00)**, VAT inclusive;

WHEREAS, the contract will be effective from January 27, 2021 to December 31, 2021;



NOW THEREFORE, the parties hereby agree and covenant as follows:

- f. Section V – Special Conditions of Contract (SCC);
- g. the Performance Security; and
- h. the Notification of Award

2. In consideration of the payment to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the required services for the Operation and Maintenance of PICC Audio Visual Equipment/System and Its Accessories subject of the public bidding in conformity with the provisions of the SCC and with a contract period from January 27, 2021 to December 31, 2021; and

3. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in Clause 11.3 of the SCC.
