and

WHEREAS, the PICCI Management, approved, the award of the contract for the said project to the CONTRACTOR, which offered the single calculated and responsive bid;


NOW THEREFORE, the parties hereby agree and covenant as follows:

1. The following documents shall be deemed to form part, and be read and construed as part, of this Agreement, viz:


- a. The Contractor's Bid Proposal submitted on December 16, 2020, including and the Eligibility, Technical, and Post Qualification Documents
