**KNOW ALL MEN BY THESE PRESENTS:**

This Agreement, entered into this 10<sup>th</sup> day of Nov 2021, in the City of Pasay, Philippines, by and between:

RENATO B. PADILLA**, hereinafter referred to as “**PICCI**”.

and

**PRIMEGOODS TRADING AND ELECTRICAL SUPPLY COMPANY**, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 38-1 Caimito Road, Brgy. 79, University Hills, Caloocan City and represented herein by its General Manager, **BENJAMIN A. OLLETA Jr.**, duly authorized for the purpose, hereinafter referred to as “**SUPPLIER**”.

**WITNESSETH: That -**

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids, for the Supply and Delivery of Twenty-One (21) units High Plasma Air Purifier for PICC Rentable Areas/Rooms and has accepted an offer from the **SUPPLIER** in the sum of **ONE MILLION SIX HUNDRED FORTY-THREE THOUSAND TWO HUNDRED EIGHT PESOS (₱1,643,208.00)**, **VAT Inclusive**;

**WHEREAS**, the PICCI Management has approved the award of the said procurement to the **SUPPLIER**, which offered the lower calculated and responsive offer;

**NOW THEREFORE**, the parties hereby agree and covenant as follows:

- b. Section VI – Schedule of Requirements;

- d. Section III – Bid Data Sheet;
- e. Section IV – General Conditions of Contract;
- f. Section V – Special Conditions of Contract (SCC);
- g. the Performance Security; and
- h. the Notification of Award.

2. In consideration of the payments to be made by the PICCI to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the PICCI to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract;

3. The PICCI hereby covenants to pay the **SUPPLIER** in consideration of the provisions of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
