**WHEREAS**, the PICCI Management, has approved, the award of the said procurement to the SUPPLIER, which offered the single calculated and responsive bid;


**NOW, THEREFORE**, the PICCI and the SUPPLIER enter into this Agreement under the following terms and conditions;



1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents:

In consideration of the payments to be made by the PICCI to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the PICCI to undertake the completion of the delivery in accordance with the Schedule of Requirements of the documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;






