**BAC Resolution Declaring LCRB and Recommending Approval**

**RESOLUTION NO. 021(05-22)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and on the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Office Uniforms for Rank and File Employee**, with a total Approved Budget for Contract (ABC) of **SEVEN HUNDRED THOUSAND PESOS (P700,000.00), VAT inclusive;**

WHEREAS, in response to the said posting, three (3) bidders obtained/paid for the bid documents, namely: LA MARINA ENTERPRISE, INC. ("La Marina"), MORIAH APPAREL HO, INC. ("Moriah") and PARIS FASHION HAUS ("PFH"). All bidders were declared eligible during the bidding on May 30, 2022, subject to post-qualification and considered their respective bid proposals, as follows:




WHEREAS, PFH, the first-ranked bidder, was post-disqualified for the reason that the sample swatches for the uniforms submitted do not comply with the specifications prescribed in the Terms of Reference; and

WHEREAS, Moriah, the second-ranked bidder, upon careful examination, validation and verification made by the Technical Working Group (TWG) of all the legal, technical and financial requirements, as well as the post-qualification documents submitted, the same were found in order. As to compliance with and/or responsiveness to the specifications of the swatches, the results of evaluation, based on the samples submitted by the bidder, were found also complying.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the award to Moriah, the aforesaid requirement, as the bidder with the Lowest Calculated and Responsive Bid whose total offer of P537,750.00 is within the ABC
