PASCUAL**, duly authorized for the purpose, hereinafter referred to as **"CONTRACTOR"**.

**WITNESSETH: That -**

**WHEREAS**, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply of Labor and Materials for the Installation of Additional Waterline at the APEC Garden and Replacement of Busted Waterline at the Forum Hall and has accepted a bid from the CONTRACTOR which gave the lowest calculated and responsive bid in the total amount of **ONE MILLION TWO HUNDRED SIXTY FIVE THOUSAND TWO HUNDRED TWENTY EIGHT PESOS AND SIXTEEN CENTAVOS (₱1,265,228.16)**, VAT inclusive;

**WHEREAS**, the PICCI Management, approved, the award of the contract for the said projects to the CONTRACTOR, which offered the lowest calculated and responsive bid;

**NOW, THEREFORE**, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

- i. Project Safety and Health Program signed by the Safety Officer;


