BAC RESOLUTION RECOMMENDING AWARD OF PROJECT

RESOLUTION NO. 41 (07-23)

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER-BIDS AND AWARDS COMMITTEE (PICC-BAC) on April 12, 2023 caused the publication in the The Manila Times of the Invitation to Bid for the Supply of Labor and Materials for the Production and Digitization of Architectural and Engineering As-built Plans of PICC Buildings and Site Development, with an Approved Budget for the Contract (ABC) of **FIFTY-ONE MILLION PESOS (P51,000,000.00), VAT inclusive**. Said invitation was also posted in the Phil-GEPS, PICC Website and in a conspicuous place at the premises of the BAC Secretariat;

WHEREAS, in response to the said posting, two (2) bidders obtained and paid for the bid documents, namely: DAYA + GARCIA INTERNATIONAL CORPORATION ("DAYA + GARCIA") and RASA SURVEYING AND REALTY ("RSAR"). Both bidders submitted bid documents and were declared eligible during the public bidding on May 25, 2023 and their bid proposals were, as follows:

WHEREAS, during the post-qualification process, the Technical Working Group (TWG), conducted an evaluation/verification on the documents as well as the post-qualification requirements submitted by the first-ranked bidder, DAYA + GARCIA INTERNATIONAL CORPORATION, and was post-disqualified, for being non-compliant, based on the TWG finding that several of its personnel failed to comply with experiential requirement for their respective positions;


WHEREAS, DAYA+GARCIA submitted a request for reconsideration of the BAC decision to post-disqualify it by explaining and elaborating the details provided in the resumes of their personnel, proving that they have indeed met the necessary number of experiential years in their respective line of work, as prescribed in Section VII (Technical Specifications) of the bidding documents for the project.


WHEREAS, in its meeting of July 20, 2023, the BAC discussed the aforesaid request for reconsideration and found the same to be meritorious.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, resolve, as it hereby resolved, as follows:

1. To reconsider its previous decision of post-disqualifying DAYA + GARCIA, and, in lieu thereof, declare it to be Lower Calculated and Responsive Bidder for the Project; and
2. To recommend to the PICC Board of Directors thru the Executive Committee, the award to DAYA + GARCIA of the aforesaid project, as the bidder with the Lower Calculated and Responsive Bid, whose total offer of P48,991,689.02 is within the ABC.
