ADDENDUM NO. 01

This Addendum is issued to amend/revise certain provisions of the Bid Documents for the above-captioned procurement. Said amendments are as follows:

I. Section III- Bid Data Sheet has been changed to read as:

- ITB Clause 5
 - **e. Must be engaged in business of supply, installation, and, repair and maintenance of escalators and elevators with PCAB license, **Category C and D, Size and Range small A (Specialty: SP-ES).****
 - **f. Must be an authorized distributor/dealer, installer and service contractor of elevators and escalators in the Philippines for the last ten (10) years.**
 - **g. Must have an After-sales Support System which is automated customer service in nature which provides 24 hours a day assistance and is available on line.**
- ITB Clause 20.2
 - **g. List of completed projects involving the supply, delivery and installation of escalators within the last ten (10) years, detailing the name of clients, brand of the escalators supplied, delivered and installed, completion dates and the contract price, contact person and the telephone numbers;**

II. Section V- Special Conditions of the Contract have been changed to read as:

- GCC Clause 2.2
 - Payment
 - **Failure to submit a bank guarantee certificate shall mean deduction of ten percent (10%) retention money as guarantee obligation for one (1) year warranty period.**


III. Section VII- Technical Specifications have been changed to read as:

- 1.1.11. Electrical Installation – electric wirings, printed circuit boards, overload protection, contactors and relays, circuit breakers, transformer, sensors, stopping devices and other requirement to ensure proper safe and free from static operation. Power/Control Transformer will be provided **by** the Contractor if indeed necessary.

- 6. Deliver to site the subject brand new replacement escalators along with its Product Testing Certificate, Certificate of Origin, Inspection Certificate, etc. Contractor is advised to deliver the new escalator/s when they are ready for installation since PICC has no available space for equipment storage. **Storage fee for the new escalators, which must be outside of PICC prior to delivery, shall be shouldered by the Contractor.**
- II. Conditions
 - The Contractor must assign the **aforementioned** key personnel with general experience for the Project.

The corrected copies are attached. Bidders are advised to replace their original copies with the corrected copies.
