

BAC Resolution Declaring as LCRB and Recommending Approval

RESOLUTION NO. 52 (06-24)

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER – BIDS AND AWARDS COMMITTEE (PICC-BAC) advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Eight (8) units LED Follow Spotlight**, with a total Approved Budget for the Contract (ABC) of **ONE MILLION SIX HUNDRED TWENTY-FIVE THOUSAND PESOS (Php1,625,000.00) VAT Inclusive**;

WHEREAS, in response to the said posting, four (4) bidders obtained and paid for the bid documents, namely: POWER COMPACT ENTERPRISES ("PCE"), STAGE CRAFT INTERNATIONAL, INC. ("Stage Craft"), MEGA SPEECHLAB ENTERPRISE ("MSE") and PRIMEGOODS TRADING AND ELECTRICAL SUPPLY CO. ("Primegoods"). All were declared eligible during the public bidding on May 23, 2024 and their bid proposals, were as follows:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by Primegoods, second-ranked bidder, the same were found in order and its bid offer in the amount of P1,350,200.00 was found to be responsive.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC Management the award to Primegoods of the aforesaid requirement as the bidder with the Lowest Calculated and Responsive Bid whose total offer of P1,350,200.00 is within the ABC.


