

BAC RESOLUTION DECLARING SCRB AND RECOMMENDING APPROVAL

RESOLUTION NO. 31(06-25)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply, Delivery and Installation of LED Lights at the Garden and Street Light along Forum Road** consisting of two (2) lots, with an Approved Budget for the Contract (ABC) of **ONE MILLION FIVE HUNDRED FOURTEEN THOUSAND PESOS (P1,514,000.00), VAT inclusive;**

WHEREAS, the sub-ABCs are as follows: **Lot I** Supply, Delivery and Installation of Street Light along Forum Road: EIGHT HUNDRED SEVENTY THOUSAND PESOS (**P870,000.00**); **Lot II** - Supply, Delivery and Installation of LED Lights at the Garden: SIX HUNDRED FORTY-FOUR THOUSAND PESOS (**P644,000.00**);


WHEREAS, in response to the said posting, two (2) bidders obtained and paid for the bid documents, namely: KIRKATE ENTERPRISES ("KE") and POWER COMPACT ENTERPRISES ("PCE"). During the public bidding on May 13, 2025, only KE submitted its documents and was declared eligible and its bid proposals were as follows:





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the award of the abovementioned contract to KE which submitted the lone calculated and responsive bid for Lot I, whose total offer of P734,388.63 is within the sub-ABC and Lot II, whose total offer of P545,422.42 is within the sub-ABC.
